Overview of responsibilities of ISD social workers:

- *Assess student needs in the area of social-emotional well being
- *Participates student's Eligibility Reviews, IEPs or Transition meetings
 - *Provide individual counseling or group therapy for students
- *Provide regular contact and support to new students
- *Provide regular contact and support to students in temporary crisis
 - *Work cooperatively with parents on issues impacting students
- *Conduct educational programs on social issues within the school and dorm setting
- *Provide support to staff who are working with students on social or emotional issues

The vision of the Ollinois School for the Deaf is to educate students to become responsible, self supporting citizens.

BASIC Q&A

Q: How do I get social work services for my ISD student?

A: Contact your child's principal or the unit social worker to discuss your concerns. A team decision will be made regarding the specific needs your student may have for services.

Q: How do I know if my student needs social work services?

A: Students are seen for a variety of reasons. If you suspect your child needs to talk with someone regarding their social/emotion needs or on-going concerns, the social worker can help you and your student make a decision regarding the possible benefits of services.

Q: What happens in a counseling session?

A: A variety of counseling activities could occur, depending on the age and needs of the student. Generally sessions consist of discussion, but may also consist of role playing, writing, drawing or other activities that are deemed appropriate by the social worker.

Q: Will the social worker share with me what my child says during counseling?

A: Confidentiality is an important part of establishing trust during counseling. While the social worker cannot share details of discussions that take place, parents can be informed regarding the general progress that is taking place.
